Whereas: SafeRide is a student run organization dedicated to protecting students and the St. Mary's community on the road and reducing the number of students who drive after drinking,

Whereas: There has been a surge in the number of students who go out on Wednesday nights to off-campus establishments,

Whereas: SafeRide is attempting to gain support and permission to run on Wednesday nights to establishments that are already serviced Thursday through Saturday nights,

Whereas: SafeRide feels that running on Wednesdays would allow them to cater to an existing need, rather than “enable” or create an increase in bar attendance,

Whereas: SafeRide is funded by the SGA, and the cost of running an additional night for the whole of next year would be \$3,668,

Whereas: There has been a clear demand for SafeRide to run on Wednesdays as displayed in our recent petition of over 450 students, (roughly 25% of the student body) and over 100 co-sponsors to this resolution,

Be it here by resolved that: The SGA endorses SafeRide's attempts to obtain permission to run on Wednesday nights and, if granted, would fund the additional Wednesday nights.
